The statistical data published in the within these services are compiled from reports supplied directly to the Organization by member and non-member countries and from other official sources of the countries concerned. Where necessary, provisional estimates, based on reported exports and/or imports, are provided.

The ICO Secretariat gratefully acknowledges the co-operation and assistance of member and non-member governments, inter-governmental and governmental bodies, public and private sector statistical organizations, trade and industry associations, market and research institutions and private companies.
