2<sup>nd</sup> World Coffee Conference Salvador, Brazil (23 – 25 September 2005)

The Chairman of the 2<sup>nd</sup> World Coffee Conference, H.E. Roberto Rodrigues (Minister of Agriculture, Livestock and Food Supply, Brazil) and the Executive Director of the International Coffee Organization (ICO), Mr. Néstor Osorio, are pleased to announce that the 2<sup>nd</sup> World Coffee Conference will take place at the Hotel Pestana Bahia in Salvador, Brazil from 23 to 25 September 2005.

The theme of the Conference is: "Lessons emerging from the crisis: new paths for the coffee sector", with three main sessions:

Session 1: Lessons emerging from the crisis Session 2: Coffee policies in a market economy

Session 3: How to develop a sustainable coffee economy

There will be an opening ceremony on the morning of 24 September, with the President of Brazil, H.E. Mr. Luiz Inácio Lula da Silva, Heads of State and Ministers from ICO Member countries and high-level representatives of multilateral donor organizations.

Néstor Osorio, ICO Executive Director, stressed the importance of the Conference as an opportunity for a detailed analysis of the state of the world coffee economy: "The importance of coffee for many developing countries is reflected in the presence of Heads of State and Ministers at the Conference. The Conference is taking place at a key time for coffee producing countries which have experienced considerable hardship with the fall in coffee prices during the last five years. Speakers and participants will analyse the causes of the recent crisis, and review current market conditions and ways of avoiding a similar situation recurring in the future. The participation of some of the most influential decision-makers in the industry together with full representation from producing and consuming countries will facilitate a free exchange of views on how to achieve a sustainable world coffee economy for the future."
