The Group will consider the following issues related to the 3 <sup>rd</sup> Forum which will take place in Brazil during the week of the 111 <sup>th</sup> Council Session from 9 to 13 September 2013 (see also document CG-4/12 Rev. 1):	
<ul style="list-style-type: none"><li>• <b>Topic</b> – a broad problem for discussion will be identified.</li><li>• <b>Format</b> – the 3<sup>rd</sup> Forum will use a force field problem-solving model. The Group will consider facilitation, breakout groups and other issues.</li><li>• <b>Participants</b> – individuals or organizations who should be invited to present or participate.</li><li>• <b>Sponsorship</b> – suggestions for potential sponsors.</li><li>• <b>Materials and information</b> – how to develop materials and information to assist with Forum discussions.</li><li>• <b>Declaration</b> – the format of an ICO declaration with recommendations for initiatives and programmes.</li></ul>	

**4. Typology of best practices – to review** verbal

As decided at the last meeting, the World Bank will develop in collaboration with the ICO, a typology of global best practices on agriculture, finance and risk management relevant to coffee, targeted at three audiences: governments, the commercial sector and producers. The representative of the World Bank will report on progress including responses received from Members.

The Group will consider how best to disseminate the results of the Forum and to message/position the Forum in a way that generates interest and participation.

**6. Considerations for future Forum events – to consider** verbal

- **Topics for future Consultative Forum events:** topics that emerged from previous Forum events that the Forum should consider; other relevant and useful topics for the Forum to explore.
