

Dear Members,

The Chair of the International Coffee Council and the Executive Director of the International Coffee Organization (ICO) present their compliments and wish to inform you of the proposed alternative arrangements regarding the 126th Session of the International Coffee Council (ICC).

As a result of the deeply concerning situation surrounding the covid-19 pandemic, the ICO has focused its attention on assessing the impact of this unprecedented challenge on the coffee sector and on the identification of mitigation measures and resources in consultation with coffee stakeholders, Members and development partners. In parallel, actions have been promptly taken to ensure the fulfilment of the 2019/20 Programme of Activities, while safeguarding the health and safety of ICO staff and Members by promoting home-based working arrangements and cancelling the in-person meeting of the 126th Session of the ICC, which was originally scheduled to be held from 27 April to 1 May 2020, at the International Maritime Organization (IMO) in London.

After consultation with several international organizations and extensive research, as well as bearing in mind the need to hold the meeting to take care of pressing matters, we have concluded that a shorter, virtual meeting of the 126<sup>th</sup> ICC is the best solution under these difficult circumstances. In our view, Article 11 of the Agreement allows for such a virtual meeting to take place.

The meeting is planned to be held virtually from 1 to 5 June 2020 as a Special Session of the Council, which, in accordance with the same Article 11, requires that requests for the meeting be submitted by at least ten Members. Therefore, we kindly ask you to review the suggested framework, schedule and agenda for this Special Session of the Council that are presented below and then submit your request that the meeting be held as proposed and any further comments you may have by Friday 24 April.

We are fully committed to maintaining a productive dialogue with all stakeholders and are confident that ICO Members will be able to engage effectively on pressing issues impacting the global coffee sector through these alternative virtual arrangements.

#### II. VIRTUAL MEETING SOFTWARE

The 126<sup>th</sup> Session of the ICC will be held using the software **GoToWebinar** (tbc). All participants will be sent further instructions regarding technical requirements to attend the virtual meeting.

#### III. ATTENDANCE

In order to provide the best virtual experience for Members and in light of technical constraints, the delegations attending the Virtual Meeting shall be limited to **one representative** who speaks on behalf of the Member.

In light of the technical limitations on the number of online attendees, the participation of observers and non-members will not be possible. Special arrangements are being evaluated for the Seminar "Addressing the impact of coronavirus on the world coffee sector", to be held on Wednesday 3 June.

#### IV. INTERPRETATION

After much research and consultations with other international organizations, we have come to the conclusion that, due to the current limitations in virtual interpretation options, the meeting should be held only in the English language. If interpretation is required, we kindly ask delegations to provide their own interpreters at their location, as has been the practice at recent international virtual conferences, such as the recent G-20 Leaders' meeting.



# V. CREDENTIALS AND REGISTRATION

In accordance with Rule 3 of the Rules of the Organization, the credentials of Member delegations shall be issued in writing to the Executive Director. Please email the credentials to <a href="mailto:credentials@ico.org">credentials@ico.org</a>.

Given the new virtual requirements, Members must submit credentials by 22 May 2020.

The registration for the virtual meeting will then be sent only to those listed on the credentials submitted to the Executive Director.
