



**Base para a distribuição inicial de votos
entre os Membros exportadores e
importadores no ano cafeeiro de 2021/22**

1. Cumprimentando os Membros, o Diretor-Executivo recorda-lhes que, nos termos do parágrafo 6 do Artigo 12 do Acordo Internacional do Café de 2007, a distribuição de votos é determinada pelo Conselho no início de cada ano cafeeiro.
2. Para que o Conselho possa decidir acerca da distribuição de votos de cada categoria de Membros no ano cafeeiro de 2021/22, é preciso, nos termos dos parágrafos 3 e 4 do Artigo 12, estabelecer o volume médio das exportações de café para todos os destinos (Membros exportadores) ou importações de todas as procedências (Membros importadores) nos quatro anos civis precedentes, ou seja, de 2017 a 2020.
3. A Revisão 1 contém dados revisados referentes ao Japão e ao Togo. A Secretaria está discutindo com o Equador e o Vietnã solicitações de correção dos respectivos dados.
4. As informações dos quadros em anexo serão usadas como base para o cálculo dos votos no ano cafeeiro de 2021/22.
