



**Basis for the initial distribution of votes
among exporting and importing Members
for coffee year 2023/24**

1. The Executive Director would like to remind Members that, under the provisions of paragraph (6) of Article 12 of the International Coffee Agreement 2007, the distribution of votes is determined by the Council at the beginning of each coffee year.
2. In order to permit the Council to take a decision on the distribution of votes for each category of Member in coffee year 2023/24, it is necessary, in accordance with the provisions of paragraphs (3) and (4) of Article 12, to establish the average volume of exports of coffee to all destinations (exporting Members) and of imports of coffee from all sources (importing Members), over the preceding four calendar years from 2019 to 2022.
3. The information contained in the attached tables will be used as the basis for the calculation of the votes in coffee year 2023/24¹.
