



Contributions to the Administrative Budget for the financial year 2004/05

1. The Executive Director presents his compliments and wishes to invite the attention of Members to the attached table showing their contributions as a consequence of the adoption by the Council on 24 September 2004 of the Administrative Budget for the financial year 2004/05 contained in document EB-3875/04.

2. These contributions are based on the rate of assessment of £1,180.00 per vote established in the Budget and have been calculated in accordance with the provisions of paragraph (2) of Article 24 of the International Coffee Agreement 2001. The contribution of each country is shown in the attached table.

As provided for in paragraph (1) of Article 25 of the Agreement, contributions are 3. payable in freely convertible currency and are now due.
