- 1. It may be noted that the next meeting of the Statistics Committee will now take place in May instead of January 2005.
- 2. The need for a special session was raised at the 91st Session of the Council so that a final decision can be taken on the premises of the Organization in January 2005.

- 5. The credentials of delegations will be examined by the Chairperson, with the assistance of the Secretariat, who will report to the Council. The List of Delegations will be based on credentials received from Members and responses received from observers.
