

> Registration for the 2nd World Coffee Conference (23 to 25 September) and credentials for the 94th Session of the Council and other ICO meetings (26 to 29 September 2005), Salvador, Brazil

1. The Executive Director presents his compliments and, on behalf of the Chairman of the 2^{nd} World Coffee Conference, wishes to remind Members about the need to register for the Conference and the field visit and to make the necessary arrangements, as indicated below.

Registration for 2nd World Coffee Conference (23 to 25 September 2005)

2. As indicated in the convocation (document ED-1954/05), registration for the 2^{nd} World Coffee Conference should be completed preferably online at www.worldcoffeeconference.com or by completing and faxing the form provided in the Convocation (attached to this document as Annex I) to RD Eventos, the conference organizers in Brazil, **no later than 29 July 2005.** Each delegation is entitled to **two** free places, and the registration fee for additional places is US\$550. The preliminary programme and other information about the Conference was circulated as document ICC-93-6.

Field visit to coffee-growing areas (Friday 30 September)

3. Members are requested to reserve a place on the field visit to coffee-growing areas in Bahia <u>as soon as possible</u>, to enable the organizers to make the necessary arrangements. There is a fee of US\$200 for the tour, and places can be reserved either online or by faxing the attached form to RD Eventos in Brazil.

Hotel and travel arrangements

4. In view of the considerable demand for hotel rooms in Salvador at this time of year, and the limited number of rooms reserved for ICO delegates, Members are requested to book

their hotel accommodation either online or by faxing the attached form to RD Eventos in Brazil. Likewise, travel arrangements should be made as soon as possible, as flights from Brazil can get very full in September.

Credentials for ICO meetings (26 to 29 September 2005)

5. Rule 3 of the *Rules of the Organization* requires Members to inform the Executive Director, in writing, of the composition of their delegations. In view of the need to finalise the arrangements for the 94th Session of the International Coffee Council and other ICO meetings from 26 to 29 September 2005, Members are requested to send their credentials with details of designated participants to the Executive Director **by 15 August 2005**.

6. Credentials should be issued in writing by the relevant Ministry or government agency of the Member country or by a representative of the Diplomatic Mission of the Member concerned either in the country where the seat of the Organization is located or where a session takes place. Faxed credentials may be accepted; however, Members are requested to provide original credentials after the session for record purposes.

7. The Secretariat will examine the credentials of delegations and report to the Council on 29 September 2005. An example of a credential is attached as Annex II for the information of Members.
