Discussions on the future of the International Coffee Agreement 2001

1. The Executive Director presents his compliments and wishes to inform Members that as decided by the Board and Council in September 2005, time for discussions on the future of the 2001 Agreement has been set aside during the ICO meetings which will take place from 30 January to 1 February 2006. Copies of the Convocation and the Agendas for the January meetings are being circulated separately (see document ED-1974/05).

Programme of work

2. The Executive Board meeting will be open to all ICO Members and observers and the Executive Director will circulate a report on progress made by the Organization in achieving the objectives of the Agreement since 2001. Members will review progress and consider proposals received from Members. The Executive Board will consider the outcome of these discussions and develop a plan of work for the future of the Agreement.

Submission of proposals

3. Members are invited to consult stakeholders in their countries and submit proposals in writing to the Executive Director on areas of possible change or addition to the 2001 Agreement.

4. These proposals should reach the Executive Director no later than **Friday 16 December** to enable them to be translated and circulated to all Members in good time for the discussions in January 2006 (either by email to info@ico.org or by fax to: +44 (0) 20 7580 6129). Annex I outlines a list of issues associated with the 2001 Agreement which Members may wish to include in their responses, and which will be used as the basis for discussions at the meeting on 31 January.

Should there be other ways to finance the work of the ICO beyond the current sources?

Continuity

Can changes sought be introduced by amendment or resolution?

Are there ways of reducing the administrative implications (particularly financial and legal) of renegotiation compared with amendment?

Other issues

Please provide any other comments on the 2001 Agreement and the ICO in relation to the discussions on the future of the Agreement.
