1. The Executive Director presents his compliments and wishes to invite the attention of Members to the attached table showing their contributions as a consequence of the approval by the Council on 29 September 2006 of the Administrative Budget for the financial year 2006/07 contained in document WP-Board No. 997/06¹.
2. These contributions are based on the rate of assessment of **£1,265.00** per vote established in the Budget and have been calculated in accordance with the provisions of paragraph (2) of Article 24 of the International Coffee Agreement 2001. The contribution of each country is shown in the attached table.
3. As provided for in paragraph (1) of Article 25 of the Agreement, contributions are payable in freely convertible currency and are now due.
