IV. PEA's Assessment of Project Progress & Prospects

IV.1 Assessment of Technical Progress

Component I (All five projects)

Activity 1.1 – Develop a coordinated framework of activities to facilitate the programme

In January 2005, Dr Sarah Simons, Deputy Director, CABI-ARC assumed the role of Regional Co-ordinator of the RCWP, to enable her predecessor, Dr George Oduor to dedicate more time to initiating a new CFC-funded project on 'Improving coffee quality in Eastern and Central Africa' (CFC/ICO/22). Dr Simons has been actively involved in the RCWP since its inception and effective coordination of the projects being implemented under the RCWP has been maintained in all participating countries throughout the reporting period. Regular communication has also been maintained with Mr Caleb Dengu, Project Manager, CFC and Mr Denis Seudieu, Chief Economist, ICO.

During the reporting period, project staff from the PEA made 21 project-related visits to the collaborating countries to facilitate project activities.

The Regional Co-ordinator also organised a CFC-funded 'Dissemination Workshop' for representatives of three of the CFC-funded coffee projects currently being implemented in Africa. The 'Dissemination Workshop' was held on the 2nd of March 2005 in conjunction with the Eastern African Fine Coffees Association 2nd Conference and Exhibition (3-5th March 2005) in Livingstone, Zambia. The workshop provided an excellent opportunity for national project staff from the CFC-funded coffee projects to interact and share ideas/information with other stakeholders participating in the EAFCA Conference and Exhibition, most notably the coffee millers, traders, marketers, policy makers, etc. It was considered by the participants to be an excellent step towards improving and strengthening the impact of coffee research and dissemination in Africa.

Financial audits of the PEA and the PIAs in each collaborating country for 2002 and 2003 were completed during the reporting period and with the exception of the reports for Ethiopia and Rwanda, which have yet to be received, the reports were forwarded to CFC. The 2004 audit is underway and should be finalised by September 2005.

IV.2 Assessment of Resource Utilisation

Overall expenditure for the reporting period is only 52% of budget. There are a number of reasons for this expenditure shortfall. Firstly, there have been delays in the submission of financial returns to the PEA by all collaborating countries. The consequence of these delays is that the figures presented in the report do not necessarily reflect the actual expenditure for the reporting period and the financial reports cannot be verified accurately by the PEA prior to the submission of the progress report. Secondly, although the pace of conducting project activities, and therefore project expenditure, has increased in all countries, there continues to be considerable room for improvement, especially in Rwanda and Uganda, during the next reporting period.

IV.3 Assessment of Project Co-ordination and Management

Overall, project co-ordination and management during the reporting period has improved as a result of frequent visits by staff from the PEA to each of the PIAs and because wherever possible meetings with the PIA were conducted with the participation of the national project co-ordinator as well as the project accountant/administrator. Joint meetings with the coordinator, scientists and administrators have greatly improved communication and understanding of the targets of the CWD project within each PEA. There has also been an improvement in the submission of claims by the PEAs, which in turn, speeds up the disbursement of funds, however, there is still room for further improvement, especially in Rwanda and Uganda.

Following a number of meetings between staff from the PEA - the Regional Project Coordinator and the Regional Project Administrator, the PIA (DRC) - the Director ONC, Professor Moyengo Makoko and the national project co-ordinator, Mr Tony Saiba Nzanzu, and the Minister for Agriculture in DRC, His Excellency, Mr Paul Musafiri Nalwango, the PEA is now optimistic that the project funds which were stolen in 2004 will be recovered from the bank following the personal intervention of the Governor of Central Bank in DRC.

IV.4 Social and Environmental Effects of Project Implementation

There are no adverse social or environmental effects as a result of project implementation.

IV.5 Forward Planning of Project Implementation

The two main priorities in the next reporting period will be scaling-up the 'raising awareness' and training activities. Raising awareness of CWD through the production and distribution of dissemination materials, coupled with the use of mass publicity i.e. Radio, TV and newspapers will be increased in each of the participating countries. Training of extension workers and farmers on the management of this CWD will also continue and be scaled-up to ensure that as many extensionists/farmers as possible are trained either directly or indirectly by the project.

More emphasis will also be given to policy analysis, in particular with regard to making recommendations on CWD to key policy makers in each of the participating countries to ensure the impact and sustainability of the project.

Results so far from the on-farm and on-station trials on methods of controlling CWD, continue to be monitored by farmers and/or extension workers. Data will be analysed during the next reporting period and discussed at the forthcoming RCWP Annual Planning and Review meeting (November 2005).

IV.6 Conclusions and Recommendations

Project activities are, for the most part, being implemented in accordance with the Workplan & Budget (2005), however, the submission of financial returns could still be improved, especially in Rwanda and Uganda.
