Decaffeinated soluble coffee: Imports and re-exports by the USA Calendar year 2011

Background

- At the 2nd meeting of the Statistics Committee held in September 2011, it was agreed that the Organization would monitor the trade of decaffeinated soluble coffee based on imports/re-exports data received from the USA – as this is the only importing Member that, so far, has expanded its Harmonised System (HS) codes to ten digits and thus enabled a more detailed identification of its products.
- 2. This document shows the monthly volume of decaffeinated soluble coffee traded by the USA in calendar year 2011 under the following HS codes:

•	2101.11.21.31	Extracts, essences and concentrates – decaffeinated –
		packaged for retail sales
•	2101.11.21.39	Extracts, essences and concentrates – decaffeinated –
		other

- The relatively small volumes imported and re-exported by the USA in 2011 for the 3. two HS codes under consideration represent only 4.4% and 7.8%, respectively, of total volume of soluble coffee traded in the 12-month period. The attached table gives details on the trade of this segment in calendar year 2011.
- 4. The Organization will continue to monitor the trade of this segment in the future.
