**Progress report on the implementation  
of the Coffee Quality-Improvement  
Programme (CQP)**

**Background**

1. Exporting and importing Members have continued to pursue their commitment to the Coffee Quality-Improvement Programme (CQP) since the adoption of Resolution number 420 in May 2004, with a view to promoting quality as a means to enhance sustainability of the coffee economy, to increase consumption, to add value and to provide consumer satisfaction (see document ICC-90-9).
2. In accordance with the Resolution, information related to the defects and moisture content, on the quality of the coffee exported is to be indicated – on a voluntary basis – in box 17 of all Certificates of Origin issued by exporting Members since 1 June 2004. The Organization would then be able to monitor the level of compliance with the target standards based on the data received.
3. This document presents a summary for the first six months of coffee year 2004/05 (October 2004 to March 2005) on Robusta gradings carried out by the London International Financial Futures and Options Exchange (LIFFE), and also provides information on progress in implementing the CQP under the provisions of Resolution number 420 in exporting Member countries in the same period based on data extracted from Certificates of Origin. Previous reports on the CQP are contained in documents WP-Quality Nos. 63/04 and 66/05.

**Action**

The Executive Board is requested to take note of this report.

1. Following the adoption of Resolution number 420 by the Council in May 2004, exporting Members have been requested to comply with the provisions of the Resolution. As compliance is voluntary, the Organization has been monitoring the information on quality received from exporting Members for coffee shipments that took place from 1 June 2004, when the Resolution came into effect. This report concentrates on information related to shipments in the first six months of the current coffee year – October 2004 to March 2005 – which may vary from country to country in accordance with the data received. See Annex Table I for details.

2. Data extracted from Certificates of Origin issued to cover coffee shipped in the first six months of coffee year 2004/05 received by the Organization – in electronic format or physical documentation – indicate that 14 exporting Members have so far fully implemented Resolution number 420. These Members are: Bolivia, Brazil, Colombia, Costa Rica, Dominican Republic, Ecuador, El Salvador, Ethiopia, Honduras, India, Mexico, Nicaragua, Papua New Guinea and Philippines. The authorities in Tanzania are still to fully implement the provisions of the Resolution in both its ports of export – in the meantime, data are partial as Certificates issued by only one port indicate the information is in accordance with the Resolution.

3. The Organization continues to monitor the daily gradings for Robusta coffee carried out by LIFFE since April 2001 at most European ports. Contacts have also been made with the New York Board of Trade (NYBOT) to ascertain whether it would be possible for a similar exercise be undertaken by the NYBOT with respect to the “C” Contract.

4. Based on LIFFE gradings results posted on its website, the Organization has been monitoring the volume of coffee by origin and by port of destination in accordance with their classification. In particular total gradings are compared with coffees classified by LIFFE under types 3, 4 and untenderable in accordance with its grading system. These grades are deemed to fall below the ICO target standards.

5. Annex Table I gives information on the total volume of green coffee by type exported by all exporting Members and by those 15 countries complying with the provisions of Resolution number 420 from October 2004 to March 2005 (coffee year 2004/05) – although information from all these countries may not be complete for the whole period.

6. During the six months (October 2004 to March 2005) nearly 42.25 million bags of green coffee have been exported. However, the total volume exported in the period based on data extracted from Certificates of Origin amounted to 33.78 million bags only – of which 24.06 million bags were exported by the 15 countries in compliance with the Resolution. A total of 23.49 million bags were exported by these 15 countries, of which 22.55 million bags are Arabica coffee, equivalent to around 96%.

7. From the total volume of coffee exported – 42.25 million bags – it is indicated that nearly 80% of the exports from October 2004 to March 2005 is based on received documents/data from exporting Members and excludes any estimates made to replace missing data (document WP-Statistics No. 85/05 gives details on each Members' compliance performance with the statistical rules of the Organization).

8. The balance of 8.47 million bags exported, on the basis of actual data received from Members, represents the volume of Robusta coffee exports, of which only 1.00 million bags are reported complying with Resolution number 420. It should be noted that effectively 7.55 million bags of this total – or 88.3% - are based on received documents/data. However, 7.62 million bags – or nearly 90% – reflect exports of Robusta coffee by exporting Members that are not volunteering the information on the quality of their coffee.

9. Annex Table II gives, for the 15 exporting Members complying with Resolution number 420, a breakdown of the total volume of green coffee exported in accordance with classification specified in the Resolution and the corresponding percentages to the relevant volume. In other words, the total volume of green coffee exported by each of these Members and the volume classified under “S” – in full compliance with the Resolution targets; “XD” – volume that falls below the defect target; “XM” – volume that falls below the moisture target; and, “XDM” – volume that falls below both defect and moisture targets. It should be noted that the data being received still include information on quality, from some of the 15 exporting Members, classified as “*Unspecified*”. It may also be noted that 88.6% of the Arabica coffee exported was classified under “S” whereas the Robusta equivalent represents only 10.9% of the total for Robusta.

10. Annex Tables III-1 and III-2 give information on the volume of LIFFE gradings by origin and by port of destination in each quarter – October to December 2004 and January to March 2005 – by grade. The results show that in the period under consideration a total of 595,833 bags from nine origins failed to comply with their quality standards. In the first quarter the volume amounted to 472,500 bags (79.3% of the total) whereas 123,333 bags (20.7%) were recorded in the second quarter. It may be noted that the amount of coffee failing to comply with the standards in the same period in 2003/04 was 947,583 bags (see document WP-Quality 63/04), indicating a decrease of just over 37% in sub-standard coffee graded.

11. The Organization will continue to monitor LIFFE gradings as well as compliance with Resolution number 420 by exporting Members.
