Progress report on the implementation of the Coffee Quality-Improvement Programme (CQP)

Background

- 1. Since the adoption of Resolution number 420 in May 2004 exporting and importing Members have reiterated their commitment to pursuing a Coffee Quality-Improvement Programme (CQP) in order to promote quality as a means to enhance sustainability of the coffee economy, to increase consumption, to add value and to provide consumer satisfaction (see document ICC-90-9).
- 2. In accordance with the Resolution, exporting Members are invited to indicate in box 17 of all Certificates of Origin issued, from 1 June 2004, information on the quality of the coffee exported by defects and moisture content. The Organization would then be able to monitor the level of compliance with the target standards based on the data received.
- 3. This document presents a summary for calendar years 2003 and 2004 of the London International Financial Futures and Options Exchange (LIFFE) Robusta gradings, and also provides information on progress in implementing the CQP under the provisions of Resolution number 420 in exporting Member countries from June to November 2004 based on data extracted from Certificates of Origin. The previous report on the CQP was contained in document WP-Quality No. 63/04.

Action

The Quality Committee is requested to take note of this report.

- 1. Following the adoption of Resolution number 420 by the Council in May 2004, exporting Members have been requested to comply with the provisions of the Resolution. As compliance is voluntary, the information on quality received from exporting Members has been monitored for coffee shipments that took place from 1 June 2004 when the Resolution came into effect. It should be noted that the period covered by the data received (June to November 2004) varies from country to country. See Annex Tables II and III for details.
- 2. Data extracted from Certificates of Origin issued to cover coffee shipped from June to November 2004 received by the Organization in electronic format or physical documentation indicate that 11 exporting Members have so far fully implemented Resolution number 420. These Members are: Bolivia, Brazil, Colombia, Costa Rica, Dominican Republic, Ecuador, El Salvador, Ethiopia, Mexico, Nicaragua and Papua New Guinea. Data extracted from Certificates of Origin issued by Tanzania for only one of its ports of export also comply with the Resolution. The authorities in this country have been requested to include the missing information on quality for all ports from which coffee is shipped.
- 3. The Organization continues to monitor the daily gradings for Robusta coffee carried out by LIFFE since April 2001 at most European ports. Contacts have also been made with the New York Board of Trade (NYBOT) to ascertain whether it would be possible for a similar exercise be undertaken by the NYBOT with respect to the "C" Contract.
- 4. Historically, LIFFE started posting gradings results on its website from April 2001. The Organization has monitored data from October 2002, when the Coffee Quality-Improvement Programme (CQP) was introduced under Resolution number 407. Annex Tables I-A and I-B show, respectively, information on volumes graded by LIFFE in calendar years 2003 and 2004 by origin and by destination by grade. In particular total gradings are compared with coffees classified by LIFFE under types 3, 4 and untenderable in accordance with its grading system. These grades are deemed to fall below the ICO target standards.
- 5. Annex Table II gives information on the total volume of green coffee by type exported by all exporting Members and by those 12 countries complying with the provisions of Resolution number 420 in the periods June to September 2004 (coffee year 2003/04) and for October and November 2004 (coffee year 2004/05) although not all of these countries have been complying since 1 June 2004 and data may not have been received from all 12 countries for coffee year 2004/05.
- 6. During the six months since the Resolution came into effect some 40.7 million bags of green coffee have been exported of which 27.2 million bags are Arabica and 13.5 million bags are Robusta. In accordance with data extracted from the Certificates of Origin issued by

the 12 exporting Members that have implemented the Resolution¹ the total volume of green coffee exported by these countries amounts to 18.7 million bags – of which, 18.2 million bags are Arabica and 0.5 million bags are Robusta.

- 7. The figures presented in paragraph 6 above indicate that 66.77% of the total volume of Arabica green coffee exported complies with the provisions of Resolution number 420 in comparison with only 3.75% of the total volume of green Robusta coffee exported in the same period. The low compliance by Robusta exporters is indicated by export data available from Brazil, Ecuador and Tanzania only. This shows that the biggest Robusta exporters, mainly Vietnam, Indonesia and most African countries, are still to implement the Resolution fully in their countries. Had data been received by all 12 countries in the period covered by this report, the total volume of Arabica green coffee exported, in compliance with the Resolution, would probably reach 80% of the total volume exported.
- 8. Annex Table III gives, for the 12 exporting Members complying with Resolution number 420, a breakdown of the volume of green coffee exported by type and by origin in accordance with classification specified in the Resolution and their corresponding percentages. In other words, the total volume of green coffee exported by each of these Members and the volume classified under "S" in full compliance with the Resolution targets; "XD" volume that falls below the defect target; "XM" volume that falls below the moisture target; and, "XDM" volume that falls below both defect and moisture targets.
- 9. The Organization will continue to monitor LIFFE gradings as well as compliance with Resolution number 420 by exporting Members.
