## Background

1. As requested by the Statistics Committee, the Secretariat has continued to monitor exports of organic coffee based on information received from exporting Members in compliance with the Rules for the application of a system of Certificates of Origin, contained in document EB-3775/01, which came into effect on 1 October 2001.

2. Data may be incomplete or partial for some exporting countries despite efforts made by most exporting Members to adjust their statistical systems to comply with the Rules.

3. The attached table shows exports of coffee labelled as "organic<sup>1</sup>" by origin, by destination and by form from October 2005 to June 2006 based on Certificates of Origin and Monthly Returns. The difference between the two sources indicates that 225,698 bags of organic coffee are not specified on the Monthly Reports as such.

4. Information extracted from the Monthly Reports shows that the value of the organic coffee exported in the period amounts to US\$13.86 million, which gives a global unit value of 139.13 US cents/lb.

5. Exporting Members will be requested to provide their Monthly Reports in the format specified in the Rules on Statistics, contained in document EB-3830/02, so that this information can be made available in the future.

## Action

The Statistics Committee is requested to take note of this document.
