- Every two years, in accordance with the Procedures for the collection, transmission, calculation and publication of group and composite prices contained in document EB-3776/01 Rev. 1, there should be a review of the market share in each group and their weightings for the calculation of the ICO composite indicator price as stated in Annex I of the document. The last review of indicator prices by the Committee took place in May 2003.
